Plein Air? Twist?

Plein Air, if you have not come across the term, means that artists pack up their gear, go outside, find a subject they would like to paint or draw or sketch or whatever and make a piece of art while they are on site. Many art groups and galleries host a Plein Air day and invite people to come to a location and make art. There is not much that's different about our project but it does "have a Twist!"

We invited people to join our project but it was not limited to one day or other short period of time. The reason for this was to give more people a chance to participate by allowing about two weeks to do their Plein Air piece. They could take their time choosing a subject and then go make their art at a time when it was convenient. Participants also knew that we would be using their art for a special show. We helped prep their work for hanging and were available to help with any of the steps in the project.

The art you will see in this exhibit is either from artists who are experienced in Plein Air or those who have never tried it before. As you view the show, enjoy the work but also listen to the stories they tell. This is exactly what art in any form does for us. When we listen to the stories each piece of art tells, it gives us opportunities to learn and get in touch with ourselves.

This is the primary goal of the Country Lawyer Gallery of the Arts. We can offer the opportunity to see many forms of art, be exposed to the beauty the artist depicts and share in those thoughts, and ideas.
